

Descendants of Thomas D. Young

Generation No. 1

1. THOMAS D.¹ YOUNG was born Bet. 1775 - 1780, and died Bet. 1836 - 1840 in Bladen County, NC. He married SARAH. She was born 1791, and died Aft. 1850 in Bladen County, NC.

Notes for THOMAS D. YOUNG:

1810 Bladen County census: Thomas Young, age 16-26, born 1784-1794, listed beside David Young. His family consisted of his wife, age 16-26, a female < 10, and a female age 10-16. David and Thomas are the only Youngs in Bladen County in 1810.

1820 Bladen County census: Tho. D. Young, age 26-45, born 1775-1794. His family consisted of his wife, age 26-45, 2 males < 10, a female < 10, and a female age 10-16.

1830 Bladen County census: Thomas Young, age 50-60, born 1770-1780. His family consisted of a male 10-15, a male 15-20, a female 30-40, a female < 5, a female 5-10, and a female 10-15.

Thomas is not listed in 1840. His wife Sarah, son William, William's wife, and William's daughter Sarah are listed in 1850.

Deed book 7, page 49:D.A. Ranaldson transfers all right to 30 acres on Goodman Swamp to Thomas Young on 16 October, 1814.

Deed book 7, page 486:

18 March, 1811.....Thomas D. Young witness to Jessop deed.

Deed book 11, page 209:

16 November, 1818 - John McGill to George Downing - \$150....153 acres on W side of Turnbull Swamp adjacent lands of Ruben Blackwell. Witnesses: William Davis and Thomas D. Young. November term, 1823.

Deed book 8, page 274:

Thomas D. Young to Nathan and William Wilson Young, sons of said Thomas D. Young - for natural love and affection which he bears his sons 152 acres on NW side of the NW River, it being the plantation whereon the said Thomas D. Young nows lives it being 1/3 of the plantation whereon John Singletary, deceased, lived on, it being the part drawn by Jane Singletary at the division of the estate of said John Singletary and sold by the said Jane Singletary to Drury A. Ranaldson and conveyed by deed of 11 July, 1813, and from Ranaldson to said Thomas D. Young excepting only the use and privilege of the said land during the natural time of my life as also the same for my wife Sarah Young. Witnesses: C. Monroe, W.B. Robeson. February term, 1836. David Lewis, Clerk.

Deed book 10, page 325 records almost exactly the same information.

Deed book 8, page 591:

30 December, 1835 - Thomas D. Young to John Monroe - \$20 - 37.5 acres on E side of Goodman Swamp. Witnesses: James S. Dunham, John Dunham. August term, 1841. David Lewis, Clerk.

No indication is given as to who Thomas' father may have been. Based on his location and age, he could be a brother of David Young, but again, no indication is given.

Notes for WILLIAM WILSON YOUNG:

Bladen County deed book 8, page 253:

1 November, 1843 - William Young and his mother Sarah Young to John T. Council - \$408.30 - 152 acres on NW side of the NW River, beginning at the lower corner of land whereon the late John Singletary formerly lived...it being 1/3 whereon the late John, deceased, formerly lived and the said William and Sarah Young being lawfully seized....Witness: R.S. Cain. February term, 1844. David Lewis, Clerk.
