Augt. 29 1845, 70 acres, less 24 acres sold to Ewin Johnson conveyed to Ephraim Hester by Robert M. Sessoms on 30 Dec. 1850. It is further agreed by said Mary Hester that the said Jonathan Singletary and wife Mary Ann who is daughter and only child & heir of the said Ephraim Hester, deceased, shall and mat have and hold all the other tracts and parcesl of land which the said Ephraim Hester died seized and possessed

Outline of Singletary Family History - Bladen County, North Carolina C. 28337

- Richard Singletary, born in England about 1599 and brought to this Country as a child, married Susannah Cook and settled in Massachusetts in 1638. Their children were Jonathan, Nathaniel, Lydie, Amos, Benjamin and Richard 2nd. There is evidence that Richard, senior, was the lost heir to the Dunham Estates.
- 2. Richard 2nd settled in 1725 in Bladen County, North Carolina, near the present town of Elizabethtown. He was the father of four sons: Monroe, Roland, Jonathan, and Richard 3rd. A land grant of this date for 50,000 acres from the Lords Proprietors to "The beloved Richard Singletary" was signed by the Earl of Clarendon.
- 3. Jonathan, wife's name unknown, had a son Jonathan 2nd.
- Jonathan 2nd married Sara Ann Harrison and had the following children: Elizabeth, Roland, David, Gainer, Sallie, Polly, Snowden, Harriet, John, and Neddie.
- 5. John (1812-1887) married Mary Anne Hester. Their children were: Joshua Kay. Braten M., Edward, Ephriam, Lucy Anne, Mary Jane, and Polly.
- 6. Joshua Kay (1844-1911) married Sarah Catherane Smith in December 20, 1866. Their children were: Isabelle Jane (Sept. 18, 1867 - William (March 23, 1868. Died same date) A.P. (June 25, 1870. Died same date.) Loula L. (April 3, 1871-) Walter Oscar (April 18, 1873 -) Mulcahy B. (Mike) (Feb.8, 1876 - June 30, 1946), John Thurman (May 17, 1878 - April 27, 1917) Dollie Amelia (May 27, 1881-Claude Robeson (April 28, 1885, -) Bertha Beatrice (July 16, 1887 -). With the exception of the last two named, who were born at the family's new home in Robeson County, N.C., all were born in Bladen County, N.C.
- 7. Walter (1873 -) Married Minnie Prudence Price in Robeson County, N.C., November 10, 1903. Their only child, Joseph Edgar, was born August 23, 1904.
- 8. Edgar (1904 -) Married Frances Carraleigh Jones of Gordonsville, Virginia, Nov. 26, 1932. Their children: Carraleigh Ann, Jan. 14, 1938, and Martha Damaris, Sept. 9, 1941, were born in Hendersonville, N.C.

Note: For purpose of this history, a son with the same first name as the father is designated by the term 2nd rather than Jr.

Note: Sources available did not provide dates and names of all family members in some cases.

Note: As this genealogical record traces the descent of one branch of the Bladen County, N.C., Singletarys only, no attemp has been made to show the descent of all families bearing the name. However, it is known that Benjamin Singletary, youngest son of the original Richard, left Massachusetts in 1695 and located at a place on the Ashley River known as the "Red Bank", near the present town of Summerville. He became the founder and head of the South Carolina branch of the family, some of whom now lives in and around Lake City, S.C. It is known that Josiah Singletary, a contemporary of Jonathan 2nd, and a son of Monroe, Roland, or Richard 3rd, settled near Thomasville, Georgia, and is probably the founder of the Georgia branch of the family.

Item: It is my will and desire the other two thirds of my personal estate likewise all my real estate be equally devided amongst my children when the Youngest arrives to the age of fourteen years old, but in case their Mother is then living in Widowhood the real estate not to be devided while she remains in that state to them their heirs, executors adminis rs and assigns forever.

And I do hereby utterly disallow revoke and disannul all other former wills by me made and I do declare this and no other to be my Last will and Testament and I do hereby nominate ordain and appoint my Two Brothers Benjamin Fitzrandolph and Ithamar Singletary to be myand whole Executors of this my last will and Testament. In witness whereof I have hereunto set my hand and seal the day and year first above written.

There has been the most sickness in this section of country that every has been since I have been in this part of the country and some deaths, David Singletary's son Edward is dead. Old Jo. Wood, Nat Singletary and Willis Singletary's son Jo has all had a severe spell of the chill and fever, but they appear to be recovering, the rest of the connection I believe the rest of the connection is in reasonable health at present. I have great reason to be entirely thankful to the Almighty for his mercy toward us it is going on eight years since we came to this place and we have never had the fever in our family as to myself I expect I have enjoyed as good health for twelve months past as I have in several years, but the power of my mind and body is fast declining. I am nearly worn out with old age and certain I am that a few more days or months will finish my existance here but I entertain a hope that I shall leave my sorrows here and arrive to that good world where the wicked cease to troble and the weary are at rest. The crops in general in this country is not very good the first of the summer was rather dry and the latter part uncommon wet which was an injury to crops of every description but cotton and peas in particular. But I think there is plenty of support made, cotton is worth from 6 dollars and a half to seven per ho. wt, pork from 3 to 4 dollars pr. ho. wt, corn from 30 to 50 ct. pr bushel coffee from 8 to 12 ponds to the dollar, salt 2 dollars and 75ct. pr sack and all kind dry goods entirly cheap. the 10th of December

I have not received a letter from that country since last fall I have wrote two letters and sent there but never has received any answer yet - I want you to send me a letter soon as you get this and want you to stake all the news good and bad and tell me all who is married and who is dead and who is moved away and all about the arrigularity of the settlement - I also want you if ever you do leave that country, I want you to come here for I think if you were here you could agr rate deal better here than there - there is I know a grate contrast among the people in that country about this -- sum says that this is not a better country than that and as to my part I do not wish to persuade any person to come - not withstanding I know that any person can do a grate deel better here than there - I will now give you a Hystry of my situation - which you prenciplely know when I left there and that was instead of gaining I was a loosing and that very fast well sir - you very well know what a large and expensive family I had - and sir when I got here I had not five dollars in the world that is in cash - and I just settled down in the wild woods where there was not a stick amiss and went to work and has supported my family better than I did there - & has bought 120 acres of land which I would not thank a man to insure me less than forty bushels to the acre of sum of it this year - I have also bought me a good stock of hogs and cows - I have cows a plenty to give me milk and shall have hogs enough to make my meet - that is if nothing happens to them and as to corn I shall make more this year than ever I maid there in five - anc cotton I shall make more than ever I maid there in my life or near as much as I ever seed made in Bladen. Now the question may be have you paid for all this the answer is I have for I do not think I owe exceeding fifty dollars in the State and that is just for my family necessarys - and so I have told you how I started and what I was when I begun in this Country - and what I am at the present - now sir

place the sam sittuation there in that Country and make an estimation of the gain and then you can come very near telling which is the best country and there is yet if you feel deposed to come to it a plenty of vacant land that one acre is worth ary fore you have got - the fact is I am not sorrow only for but one thing in moving to this country and that is I didnot come soon enough - I have also increast in Negros sence I left that country Sally has one very fine body and if nothing happens she will have another in about two months - I want you if you if you please in the devesion of mammy property if there is any thing coming to me or anything that she requested me to have I want you to let me know it and Ile fix sum way to git it here - I have no more at present as I no of only I can say that I should be glad to be there long enough see you all one time more but not stay there for I would not have no place in that Country as a gift and obledge me to live on it - I want you soon as you git this letter to send me an answer so, I will conclude my letter by subscribing myself your most loving and affectionate sister till death.

"First" I give and bequeath to my beloved wife Sarah Singletary, fifty acres of land including my dwelling and out houses and as much cleared land as shall be sufficient for her subsistence, also my negro man "Mingo", my bay mare and one plow and gear, one ex, one hoe, two beds and furniture with bedsteads, all my kitchen furniture, four cows and calves, half of my stock of hogs, and sheep and half of my bee-hives, during her natural life.

"Second" I give and bequeath to my son Peter Singletary that part of my cleared land be it more or less which I shall have marked off with stakes next towards my dwelling house, as also at the death of my beloved wife Sarah that part of land above described given to her during her natural life, also the two beds and furniture above named, also one horse named "Roebuck", also I desire that my stock of cattle, hogs, sheep and bees, be equally divided between my sons, Peter and John, and daughters Sidney, Sophia, Nepsey and Amelia.

"Third" I give and bequeath to my daughter Amelia one bed and furniture also one hundred and fifty acres of land, called Byrnes Marsh.

INFORMATION FROM THE PENSION APPLICATION OF JOSIAH SINGLETARY. BLADEN COUNTY, NORTH CAROLINA

Answers to the Interrogations prescribed by the War Department, as propounded to the Applicant by the Court.

- 1. I was born in Bladen County, October 2#gh, 1763
- There was a record of my age in my mother's possession until her death, and I believe my Brother Joseph Singletary carried it with him to Florida, where he now resides.
- 3. In Bladen County, and have resided there ever since.
- I was a substitute in Capt. Bullock's and a Volunteer in Capt. Irwins Compy.
- 5. For answer, I beg leave to refer to the body of my Declaration
- 6. I never received but one discharge, which was for one months' service under Capt. Bullock & which I have lost.
- 7. The Revd. Elias Davis, William Parker, David Pate, Jonathan Singletary, Thomas Hester, Colonel Richd. M. Lewis, Colin Munroe, and others, whom he could name were it necessary.

Sarah Singletary in her affidavit dated 29 March 1854 states that she is aged 76 years, that she is the widow of Josiah Singletary, deceased, a Revolutionary War soldier, she states she was married to the said Josiah Singletary on the 4th July 1833, and that he husband died in the year 1843 of 1844.

In the affidavits of Henry Hilburn he states that Josiah Singletary died on the 18th of September 1843 and that Sarah P. Singletary is his widow, and that he never knew of any other pensioner of that name within the said County (Bladen).

Evidently Sarah P. Singletary died Oct. 7, 1857, as there is such notation on her pension application.

And I do hereby disallow, revoke and disannull all other former wills by me made and I do declare this and no other to be my last will and testament.

And I do hereby nominate, ordain and appoint my two brothers, Benjamin FitzRandolph and Johannas Singletary to be my true and lawful and whole Executors of this my last Will and Testament.

I notice in the Will of John Willis that he refers to the land he bought from Harmon Singletary.

I have a large file on the Singletary Family as well as the Willis family. Do you think Alice could be a Willis? As soon as I have an opportunity I'll look for any information that might give a lead on the parents of Harmon.

We had many records destroyed by fire, but we also have many records which were recopied. One of the earliest lands granted in Bladen County was to RICHARD SINGLETARY. In your New England records by Savage, there is a reference to Richard Singletary who moved to North Carolina. Richard is also listed in the North Carolina Colonial Records as being one of the three freeholders in Bladen County when it was formed in 1734. I would give anything to be able to connect and document this family, since it is one of the first.
