On this 24th day of March 1852,

Personally appeared before me a Justice of the Peace in and for said County, John Melvin, a resident of the State and County aforesaid, aged 90 years, who being first duly sworn according to law, doth on his oath, make the following declaration in order to obtain the benefit of the act of Congress passed June 7th 1832, That he entered the Service of the United States under the following named Officer and that he served as herein stated: He hereby relinquishes every claim whatever to a pension or annuity except the present, and declares that his name is not on the pension roll of the Agency of States. Sworn to and subscribed the day and year aforesaid.

A. In North Carolina Bladen County in the year 1762,

Q. 2nd Have you any record of your age, if so where is it.

A. I have no record it was destroyed by fire.

Q. 3rd Where were you living when called into service; where have you lived since the Revolutionary war, and where do you now live?

A. In North Carolina Bladen County at each period.

Q. 4th How were you called into service; were you drafted, did you volunteer, or were you a substitute?

A. I volunteered.

Q. 5. State the names of some of the regular Officers who were with the troops when you served.

such continental and militia regiments as you can
recollect, and the general circumstances of your service.
A. Genl. Thomas Brown, marched us from Elizabethtown
in Bladen County, to a station on Drowning Creek
near the South Carolina line, where the Tories were
committing depredations. we remained in Camp
there three months, and Genl. Brown, then, marched us
back to Elizabethtown, and told us to go home.
John Gaetz was our Captain there, I think. I cannot
recollect what year or month that was; after I was
discharged by Genl. Brown at Elizabethtown; I think I stayed
home about twelve months, and then went to Wilmington
in N. Carolina, and joined a militia regiment or
company that was stationed there as a volunteer,
for a twelve months term, before the time expired.
peace was made, I think I was in Wilmington
about six months. Jeremiah Botgrose was Major there,
and I think Wm. M. Ree was a recruiting officer at
that time, and went north. I cannot recollect the
militia regiment I was attached to at either Station.

Q. 6th Did you ever receive a discharge from the service; and
if so, by whom was it given, and what has become of it?
A. I never received a written discharge.

Q. 7th State some of the names of persons to who you are
known in your present neighborhood, and who
can testify as to your character for veracity and their
belief of your service as a soldier of the Revolution?
A. Daniel McPeffer & Thomas Smith.

I do not know of any surviving witnesses who could testify
as to my personal service as aforesaid. William Smith Sr.
of this County, who served with me in my first term, received
a pension during his life time; he died a few years ago.
Daniel W. Foster, or his heirs; who served with me in my last term,
I understood, was entitled to or had received land & pension.

 And I the said Joseph T. Melvin, a Justice of the Peace, do hereby declare
 that I believe, that after the investigation of the matter, and after
 putting the interrogatories prescribed by the War Department, that
 the above named applicant was a revolutionary soldier and ser-
 ved as he states.

 age, and the consequent loss of memory, he cannot trace pre-

 ods mentioned below, as a private served three months
 in Camp, on Deepening Creek in N. Carolina, served
 six months in Wilmington N. Carolina as a private,
 and for such service claims a pension.
