- **Burke County, NC, Deeds Registered 1804-1813**--Abstracted from the minutes of the court of Pleas & Quarter Sessions. Soft-cover, stapled & taped binding. 84 pp. **\$12.00**
- **Burke County, NC Deed Book A**--Begins in 1866. As earlier deeds were destroyed at the close of the Civil War, land-owners were urged to re-register deeds in this time period. Soft-cover, stapled & taped binding. 81 pp. **\$12.00**
- **Cemeteries of Burke County, NC Vols. I, II, III, IV**--Indexed listings for burials in most cemeteries in Burke County, published 1995-2001. Soft-cover, with stapled & taped binding. Approx. 200 pages each.

- **Index to Marriage Registers, 1867-1908, Burke County, NC**--Listings from five volumes of black and white marriages. Separate listings for bride and groom. For some marriages listed here, there are no extant certificates. Soft-cover, stapled & taped binding. 218 pp. **\$24.00**
- **Treasury Book of J. L. Laxton, Burke County, NC 1875-1878**--Local names, especially of the indigent who received county funds, appear in this book. Soft-cover, saddle-stitched. 58 pp. **\$10.00**
- **Burke County Federal Census**--Each book contains the Federal Census records transcribed for the indicated year.

- **Burke County Grandfather Book**--A transcription of the "Permanent Voter Registration Book" established by North Carolina's 'Grandfather Law' at the beginning of the twentieth century, contains the names, locations, and a 'voting ancestor' for most men in the county, 1902-1908. - **Where Are the Early Burke County Records?**--In this 15-page paper, Betsy Dodd Pittman discusses what county records have been lost, which still exist, and where they may be found. Soft-cover, stapled. **\$2.00**
- **Tax Lists and Related Documents of Old Burke County 1760-1839 & 1864, Annotated and Indexed**--Includes transcriptions from all the tax lists that are available for Old Burke County which included parts of Alexander, Avery, Burke, Caldwell, Catawba, Cleveland, McDowell, Mitchell, Rutherford, and Yancey Counties. Information varies but may include people's names, amount of land, land value, number of white and black polls (polls were men of military age), stud horses, and location of land. We have identified and added present day locations, informational articles, and a full name index. This is a set of 3 volumes. The books are hard bound, about 8½ x 11 x 1, total 848 pages. **\$95.00**
- **Transcribed Burke County, North Carolina Road Records** --Prior to the establishment of the Department of Transportation, the court ordered able-bodied landowners under 45 to select the path for roads, cut them out, and then maintain them. An overseer was appointed and his neighbors, often including young men still in their fathers' home and not listed on a pre-1850 census, were named to carry out the work. We have transcribed **word by word all the readable information** contained in the five boxes of road records dated 1787-1897, and some undated, that are located in the North Carolina State Archives. Names are spelled exactly as they appeared. This is a set of 4 volumes. The books are hard bound, about 8½ x 11 x 1, total 1252 pages, and include a full name index. **\$125.00**
