the Survey into the Secretary's Office; fail not as you will answer the contrary:

Debt or sum of money aforesaid, exactuance, or other discharge, for me and
in my name to make suit and action of these acts whatsoever in Law for the recov-
ery of all or any suits for me and in my name, if I were there in my own
Person present and whatsoever my attorney shall lawfully do or cause to be done
in or about the Execution of the Promises by virtue of these Presents at this
first Day of July 1702.
