The petition of Barbary Day, widow of Jno Day, Sr agst John Day, Henry Day, Elijah Day, Philip Day, Ambrose Day, Bolling Day, ____ Clayton this [?] Nancy, ____ & Virginia [?] his wife, James Satterfield his wife Francis, Hiram Oakley his wife Elziabeth and Franky Cochran, Wm Cochran, Albert Cochran, Robert Cochran, Children of Jno Cochran & his wife Sarah Ann decd, with said Cochran, Children aforesaid are minors & heir next friend, ____ pending this list, Jno Day.

The petitioner states, that she is the widow of Jno Day, Sr, late of this county, who diede Intestate, seized & possessed of a tract of land in said county on the waters of Tar River adjoining the lands of Jaas Webb, ____, containing about 555 acres. She states, that the aforesaid Defendants are the Heirs at law of the said John Day: Elijah Day, Philip Day, Richd Clayton for his wife, Munford Sand__ his wife, James Satterfield his wife, and the minor children of Jno Cochran & his wife, are not inhabitants of this State but are residents of the State of Tennessee, and that the other defendants are Inhabitants of this County: She prays that your worships would make such as is the principals or may be proper [?] ____ the said portion, ____ before this court, and make your worships ____ Jury of good lawful men in the ____ to lay off to her Dowry in the said lands ____ in proportion of this same ____ therefore in this Court: ____ - ____ we pray

In this case it appearing to the Court, that the Defendants John Day, Henry Day, Ambrose Day, Bowling Day, Hiram Oakley & his wife Elizabeth, who reside in this county ____ of this Petition for Dower & the proceeding ____ they ____ all ____ for the ____ pf services of a copy for the petitions & other more formal ____, if is ____ & the Court, that ____ for these weeks be had in the Relief ____ for the other defendants & ____ of the ____ of this Court, an ____ this petition or judgement will be explained against them.

(Person County Court December Term, 1825)

In abeyance to an order of Court December Term 1825 directed to the Shff Commanding him to Summons a Jury of Lawful men to lay off and allot to Barbary Day Widow of John Day Sr Decd one third part of the Land which the said John Day Senr died seized and possessed of We the undersigned Jurors after having been duly Summoned and Sworn by the Shff aforesaid did on the 13th day of January AD 1826 proceed to the Execution of the same in manner & form as follows to wit Beginning at a stake in the old field running wi? Line chain to the Spring thence south eleven chain & ten links to James Webbs line thence west forty one chain & thirty seven links to a stake in Johnstons line thence north on said Johnstons line twenty nine chain & thirty seven links to a Hickory Bush thence east forty seven chains & thirty seven links to a stake in the edge of an old field thence south to the first station Containing by estimation one hundred & Eighty five acres moor or less to her the said Barbary to her the said Barbary Day to have and to hold the aforesaid one hundred & eighty five acres of land aforesaid during her life free from the claim or claims of any other person what ever in testimony whereof we have hereunto set our hand & seals the day and date aforesaid.
