Dear Mr. White:

Pardon my not having written. I've just been enjoying life too much to write anyone very frequently. I have done a little more searching for you. Enclosed you will find copies of documents in the Lincoln County, N.C. estates files in the N.C. Archives.

One paper is a statement, apparently in your James White's handwriting, declaring his intentions to have his lands processed.

The others are administration papers on Edward White's estate. Note that his widow Letisha states she wishes her brother-in-law **James White** to administer the estate. Then note the signature of James on the administration bond. It is the same as on the land processioning paper, the same as on his 1823 will, and the same as the witness to Samuel White's will. Compare them, particularly the J, s, and W.

There appear to be two James Whites; the one in Charles Town being there in 1774, two years after your James had moved to Tryon Co., N.C.

Lucy Givens appears to be the widow of Robert, and I consider that she is buried in Long Creek cemetery in NC.

Robert Givens surely died between 1771 and 1774 in Chester Co., Pa. You should try to obtain a copy of a will or other estate papers. There were several Givenses down toward the Catawba River at an early date, and I would suggest that they were part of Robert and Lucy's family.

I have made no more progress on my James White. He appears to be closely allied with those on First Broad River in present Cleveland County, NC. They were Jeremiah, Stephen, Augustin, Isaac, Thomas, etc. Isaac and Thomas were transients from over on Long Creek. I know nothing of the others.
