Two Cows and yearlings now in his own Possesion I give as abov  
mentioned  
Item I give and Bequeath unto my Son Ezekiel watts  
Three Cows and calves and a Bull and a Sow and Pigs two  
feather Beds all now in Possesion of him likewise Two hundred  
Acres of land Lying on the North Side of Gap way  
holding of the Mill works I Give to his younger Daughter  
Mary watts <sup>fifty</sup> Three hundred acres of  
Item I give to my Son Philip watts <sup>fifty</sup> Three hundred acres of  
Land <sup>young</sup> fifty in Columbus County Betwixt my Plantation  
Richard watts my son, and the other ~~three hundred~~ <sup>two hundred</sup>  
In South Carolina joining the feathery & William Nortons line  
to Conctud three hundred acres Two Cows and calves and  
a two year old Heifer Three head of Sheep the Colt that my  
Mare is with <sup>two</sup> <sup>with</sup> <sup>now</sup> one feather Bed a Musket Gun  
Item I give to Daughter Senelope watts Three hundred acres  
of land lying in the South State In the same Survey with  
rest Two Cows and calves and a two year old piiper Three head of  
Sheep one feather Bed  
Item I give to My Son John watts Three hundred acres of land  
In the South State in <sup>the</sup> Survey Two Cows and calves and a two year  
heifer Three head of Sheep a Musket Gun a three year old mare  
Widdle axe Saddle and My Plantation that I live on at this

ing all former wills and Testaments where unto I have  
Set my hand and Seal this the 25<sup>th</sup> of January 1811.
