### **Henry Rhodes, Sr - Onslow County, NC**

DEED-9 March 1731-Bertie Co., N.C.

Henry ROADS and wife Mary of "Onsloe" Precinct on New River, to Thomas PARKER of Chowan Precinct.

9 March 1731. 130 pds, 400 acres on Cypress Swamp at Tumbling Branch, adj. John BRYAN. Witn: John PARKER, Joseph PARKER, James PARKER.

Will written 14 Sept. 1751, witnessed by Thomas RHODES, Joshua PAULL, & Patience JOHNSTON. Son, Thomas RHODES proved will in court

2 Oct. 1751, registered in Craven Co. Wife, Mary and son Henry RHODES, named executors; but Thomas given executorship. Henry bequeathed Manor Plantation, mill & liquor still, others named brother Thomas RHODES, and brother in law Daniel MASHBURN. Negro: KATE to wife Mary, then to Henry.

Granddaughter Elizabeth, also named. Negro: QUASH, for Henry, Jr. then to Thomas.
