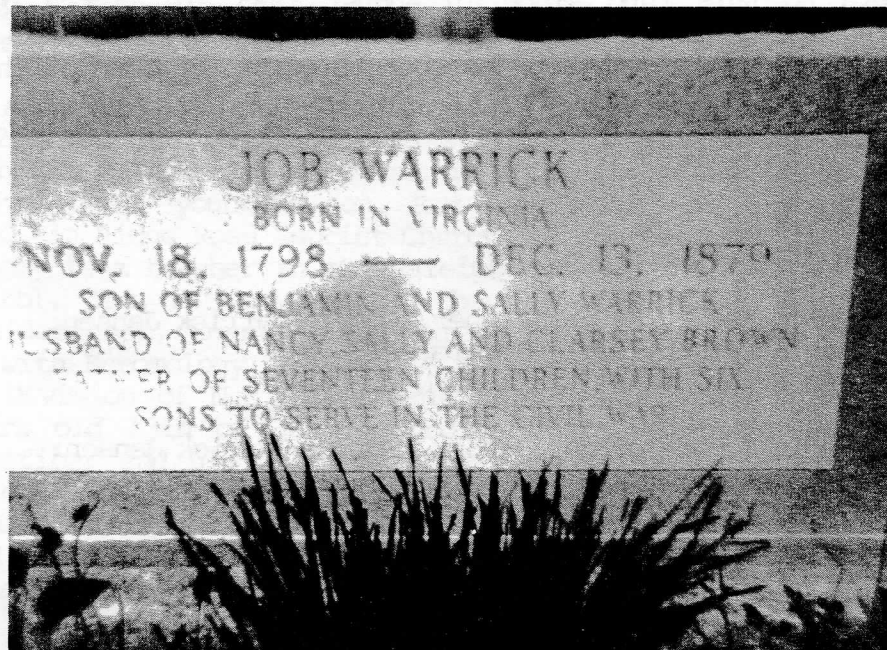

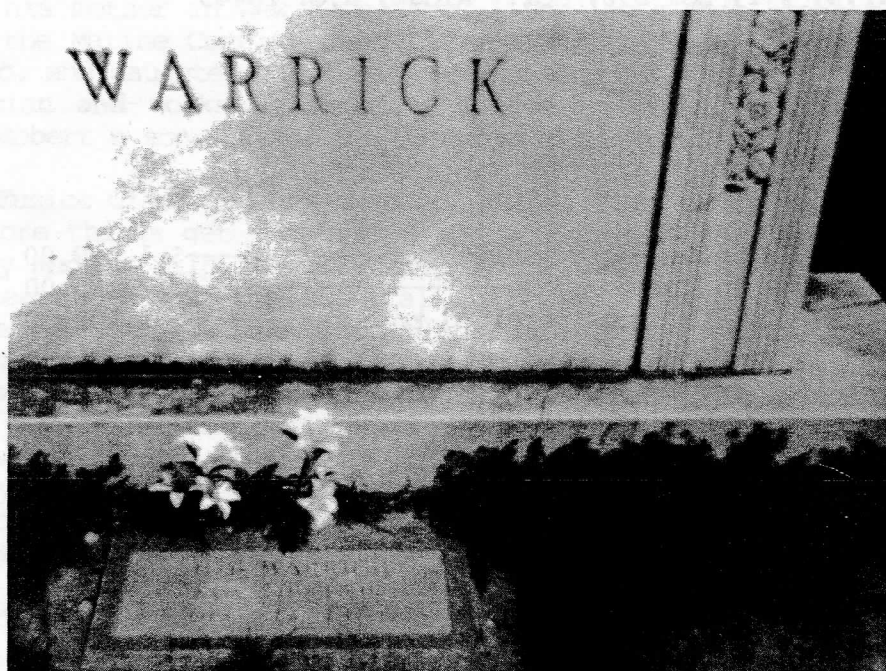

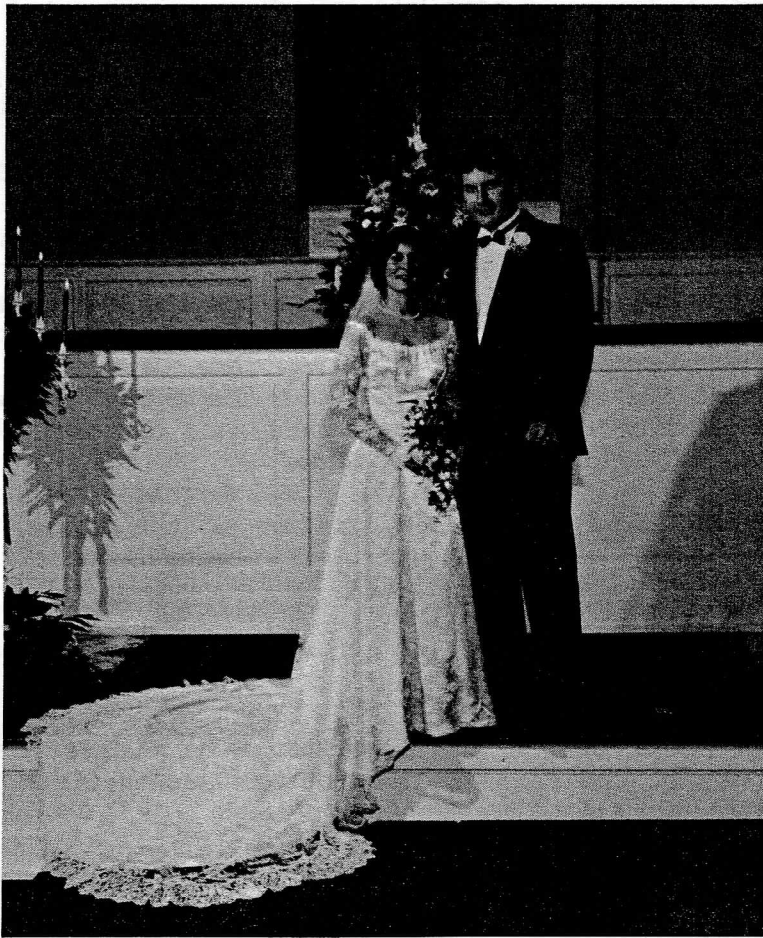

**THOMAS UNDERWOOD** married 10 March 1783, Sampson Co., **SARAH THORNTON**. He received a land grant in Sampson County, N.C. for 200 acres on the east side of Bearskin Swamp adjoining land he already owned. **THOMAS UNDERWOOD** died 4 April 1803 at age 60 and was buried in Salemburg cemetery. REPORT OF THE COMMITTEE  
ON THE ESTATE  
OF  
THOMAS UNDERWOOD, DECEASED  
Sampson County, North Carolina

In observance to an order of the County Court of Sampson, February Term 1821 designating us the undersigned a Committee to settle the Estate of Thomas Underwood, deceased with Nataniel Thornton and Thomas Thornton, Executors of said deceased ie

Report we find by the papers rendered by the court they had in their possession five years after Executorship, the sum of \$64.20 after the commissions were allowed and deducted, leaving the above sum as balance. Interest on the above 16 years is added \$125.83. Vouchers in the hand of Exr. returned from William Jackson in right of his wife, Ann \$7.12, dated February 21, 1807 -Interest. \$94.94 to him is yet due. Ditto from Josiah Underwood \$7.12 March 9th 1811 - yet due him \$56. for Interest. Ditto from John Underwood \$7.12 uet due him for Interest \$3.36. Ditto from David Underwood the same as next one due \$3.36. dated each 20 March 1813. Ditto from Sarah Jackson (dau of sd dec'd) Fevruary Term 1814 for the sum of \$7.12 and due for Interest \$3.78 Ditto from Sampson Underwood May 19th 1818 the sum of \$7.12. It leaves due for Interest \$5.46. Also received from Timothy Underwood a receipt for \$7.12 and remains due to him the sum of \$5.04 dated March 16th 1817. Due to Ellender Underwood also to Charles Bulles in right of his wife Rebah. Each the sum of \$13.46 cents.

The Plaintiff complaining alleges and says

1. That he is one of the heirs of Sampson Underwood, deceased and of the lawful age of 21 years and upwards.

2. That Averett Thornton, deceased, was at February Term 1829 of the Court of Pleas & Quarter Session of Sampson County and appointed Guardian of the plaintiff. Daniel Joiner, Thomas and John Ingram Underwood entered into bond payable to the State of North Carolina in the sum of one thousand dollars for the faithful performance of his duties as Guardian as aforesaid with Thomas Thornton and Eldridge Thornton as securities on said guardian bond as appears from the records of said court.

3. That said Guardian bond has been lost or misplaced.

4. That the said Averett Thornton died intestate before the commencement of this suit and R. W. Thornton is his Administrator.

5. That the said Averett Thornton, deceased, as Guardian of said plaintiff has never accounted with this plaintiff, nor any action personal for him for the property belonging to said plaintiff and which came into his hands as his Guardian. That the said Averett Thornton, Guardian, as aforesaid received into his hands property amounting to at least five hundred dollars and by his gross neglect and inattention has never accounted for or made any returns of the same during the entire period of his said Guardianship and there is still due the plaintiff his proportional part of said estate as one of the heirs a considerable sum, to wit, in the amount not less than five hundred dollars as he verily believes and which he asks may be inquired into by the court.

Wherefore the plaintiff dismissed suit against the defendant for the sum of one thousand dollars the amount of the said guardian bond and for the costs of this action and all other and further relief as the plaintiff may be entitled to.

The larger monument with inscriptions was placed at the grave of Job Warrick, Sr. in the family cemetery on the old farm at Grantham, N.C. on county road SR 1203 adjacent to Horse Swamp. The smaller stone, which states the location of the grave of Job Warrick, Sr., was placed at the Falling Creek Baptist Church at Grantham in the Warrick plot. Those in attendance when stones were placed in November 1986 by McLamb Monument Company were: George Warrick, Leslie Warrick and Woodley Warrick.

Josiah Warrick was born 6 August 1826 to Job and Nancy Warrick. He was born in either Sampson or Duplin County, N.C. He married Eliza Oates likely before leaving N.C. There were many Oates in Sampson County in the early 1800's. He was first listed in U.S. Census of Coosa County, Alabama in 1850. Apparently he moved his family to the vicinity of Greenville, Ala. prior to the Civil War. On 13 March 1862, he enlisted in the army at Greenville, Ala. He served as a private in Company I, 39th Regiment, Alabama Infantry. He was captured at Petersburg, Va. on 17 June 1864 and was transferred immediately to Elmira, N.Y. On 11 October 1864, he was transferred from Elmira for exchange. He died at Fort Monroe, Virginia on 31 October 1864 and is buried in the Hampton National Cemetery, Hampton, Virginia. Eliza Oates Warrick died 12 March 1896.

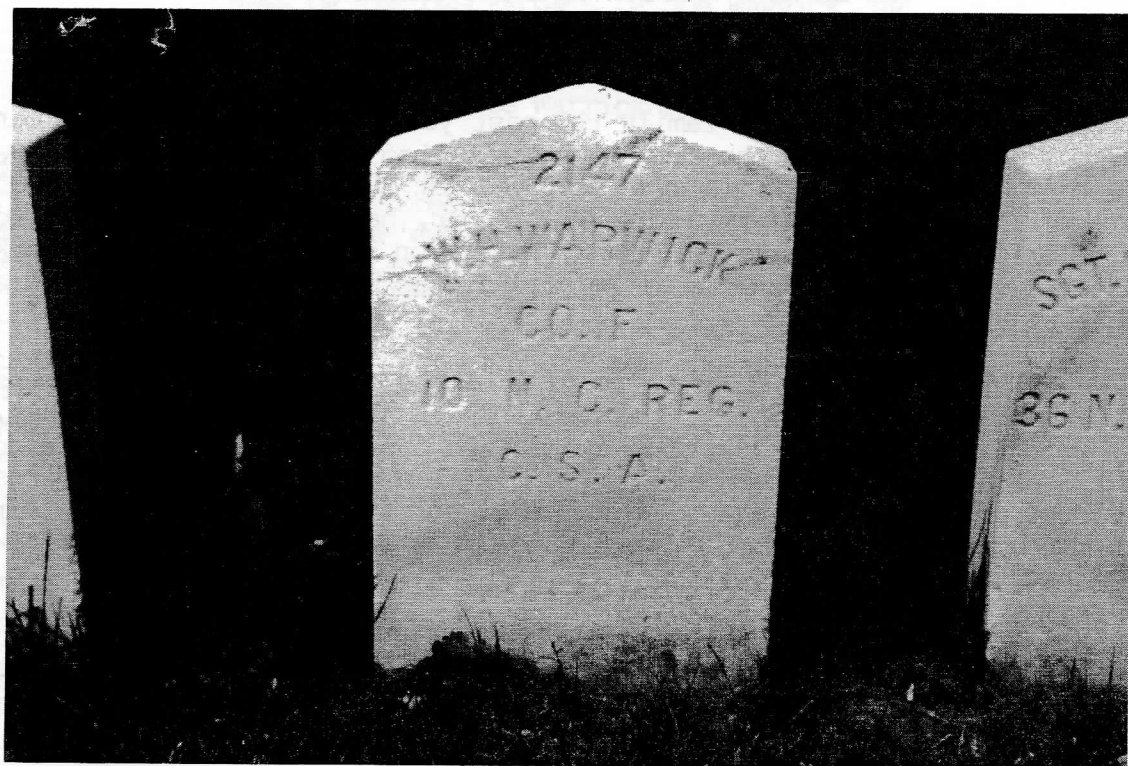
